#### **INSTRUCTIONS TO BIDDERS (ITB)**

#### Section – A

#### 1. General Guidance for e-Tendering

**1.1** Instructions / Guidelines for e-Tenderers for electronic submission of the e-Tenders online have been shown in Web site <a href="https://wbtenders.gov.in">https://wbtenders.gov.in</a>

#### 1.2 Registration of Bidders

Any bidder willing to take part in the process of e-Tendering will have to be enrolled and registered with the Government e-Procurement System.

#### 1.3 Digital Signature Certificate (DSC)

Each bidder is required to obtain a Class-III Digital Signature Certificate (DSC) for submission of e-Tenders.

#### 1.4 Collection of e-Tender Documents

The bidder can search and download NIT and e-Tender documents electronically from computer once he logs on to the website mentioned in Clause 1.1 using the Digital Signature Certificate. This is the only mode of collection of e-Tender documents.

#### 1.5 Participation in proposed work

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm or registered company.

#### 2. Submission of e-Tenders:

#### 2.1 General process of submission:

Tenders are to be submitted online through the website stated in Clause 1.1 in two folders, one is Technical Proposal and the other is Financial Proposal, before the prescribed date and time mentioned in the list attached. Using the Digital Signature Certificate (DSC), the documents are to be uploaded, virus scanned and digitally signed. Tenderers should specially take note of all the addendum/corrigendum related to the e-Tender and upload the latest documents as part of the e-Tender.

#### 2.2 Technical Proposal

The Technical Proposal should contain scanned copies and/or a declaration in standardized formats of the following in two covers (folders).

#### A. Technical File (Statutory Cover) containing

- i. NOTICE INVITING E-TENDER (NIT) (to be submitted in "NIT" Folder).
- ii.Section B (Form I, Form-II, Form-IV, Form-V and AFFIDAVIT Y) (to be submitted in "FORMS" Folder), as the proposed tender will be evaluated under QCBS method.
- iii. **Earnest Money Deposit (EMD)** by the Tenderer as mentioned in the NIT document in favour of "The Conservator of Forests & Joint Chief Executive Officer, WB CAMPA".
- iv. Instructions to Bidders. (to be submitted in "ITB" Folder)
- v. General Terms & Conditions of Contract. (to be submitted in "GT AND CC" Folder)
- vi. Technical Specification. (to be submitted in "TS" Folder)
  - i) Tender fee of Rs. 500/-(Rupees Five hundred only) which is non-refundable and is required to be submitted by all intending bidders through GRIPS Portal. (https://wbifms.gov.in/GRIPS/makePaymentInt.do)

Select 'Forest Department' - 'Receipt of Tender Fees relating to works under CAMPA'. Select 'Circle' as WB CAMPA (HQ).

Earnest Money Deposit (EMD) @2% on estimated value of the tender (i.e., Rs. 4,00,000/-) amounting to Rs. 8,000/-(Rupees Eight thousand only) is required to be paid by all intending bidders through ICICI Payment Gateway. Under any circumstances the Earnest Money so deposited shall not bear any interest.

(Detailed procedure is described in order no. 3975-F(Y) dated 28<sup>th</sup> July, 2016 of Finance Department, Govt. of WB). A copy of challan / receipt obtained after deposition of tender feeand EMD should be submitted along with tender documents.

ii) Addenda/Corrigenda, if published: Bidder are to keep track of all the Addendum/Corrigendum issued with a particular e-Tender and upload all the above, digitally signed, along with the NIT. Tenders submitted without the Addendum/Corrigendum will be treated as invalid and liable to be rejected.

#### 2.3. Financial Proposal

- i) The financial proposal should contain the Bill of Quantities (B.O.Q.) in one cover (folder). The bidder is to quote the rate in the space marked for quoting rate in the B.O.Q. The financial quote should be Comprehensive including travelling, lodging and out of pocket expenses, statutory Tax like GST etc.
- ii) Only downloaded copy of the B.O.Q. are to be uploaded quoting the rate, virus scanned & digitally signed by the bidder.

#### 3. Eligibility Criteria for participation in e-Tender:

(a) All categories of prospective Tenderers shall have to submit valid and up to date Professional Tax receipt challan, **GST registration certificate**, Income Tax return Acknowledgement receipt, PAN card issued by Income Tax Department, and Trade license in respect of the prospective Tenderer. Bonafide organizations having experience of similar nature of work during the last 3 financial years any Government Department, Zilla Parishad, Government undertaking / Statutory Bodies constituted under the statute of the Government may apply for the Tender. The intending bidders must be having financial credential of similar nature as per NIT. The financial credentials thus submitted should not be more than three years' old.

In addition to the above, any bidder who has executed any type of e-Tender works in Directorate of Forests, Govt. Of West Bengal, should submit previous credentials for his past performance, completion certificate from respective employer, the completion certificate and credentials should be signed by the officer not below the rank of Deputy Conservator of Forest, any other certificate signed by other officials will not be entertained (Non-Statutory Documents).

Intending bidders shall be required to submit credential of similar nature of works during the last 3 financial years to any Government Department (Central / State), Zilla Parishad, Government Undertaking / Statutory Bodies constituted under the statute of the Government. All categories of intending Organization shall have satisfactorily completed as a prime agency during the last 03 (three) years prior to the date of issue of this Tender Notice either of the following:

- i. At least one job of similar nature with an estimated cost equals to 50% or more than the estimated cost put to this NIT; or
- ii. At least two jobs of similar nature with an estimated cost of each of the works equal to at least 25% of the estimated cost put to this NIT in any one year; or
- iii. At least three jobs of similar nature with an estimated cost of each of the works equal to at least 20% of the estimated cost put to this NIT in any one year,

For the purpose of this work, 'similar works' mean monitoring, review, interim monitoring, evaluation etc. in any Government Department, Zilla Parishad, Government undertaking / Statutory Bodies constituted under the statute of the Government.

Copy of last Income tax Submission Certificate, Copy of Last GST submission certificate, Copy of PAN, GST Registration, Receipt on submission of EMD deposit (Original) and Tender Fee, Details of Financial Credentials, past credential of carrying out similar nature of works are required.

- (b) Where an individual person holds a Certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while submitting any e-Tender for and on behalf of such company or firm, invariably submit a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to submit such e-Tender. The Power of Attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908. (Non-statutory Documents).
- (c) Neither prospective Tenderer nor any of the constituent partners had been debarred to participate in any e-Tender by Forest Dept., P.W.D., P.W.(R)D & P.W.(C.B.)D, Housing Department, W.B. or C.P.W.D. or M.E.S or Railways during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format). [Non-statutory Documents]
- (d) The prospective Tenderers or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.
- (e) A prospective Tenderer shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If the prospective Tenderer is found to have applied severally in a single job, all his applications will be rejected for that job.
- (f) No conditional / incomplete e-Tender will be accepted under any circumstances.
- (g) The Financial Eligibility:

The bidder should have a minimum average annual turnover of least 100% of estimated project cost of the e-Tender in the last three 3 preceding years (the turnover of the lead member will be considered in case of joint venture).

#### 4. Opening of Technical Proposal& Finalization of Bids:

Technical proposals will be opened by the authorized representatives electronically from the website stated in Clause 2.1, using their Digital Signature Certificate.

Intending Tenderers may remain present, at the time of opening of e-Tender, if they so desire.

Cover (Folder) for Statutory Documents should be opened first, if found in order, Cover (Folder) for Non-statutory Documents will be opened. If there is any deficiency in the Documents, the e-Tender will summarily be rejected.

Decrypted (transformed into readable formats) documents of the Non statutory Cover will be downloaded, and handed over to the e-Tender Evaluation Committee (constituted for evaluation of e-Tenders).

# The Evaluation of the tender will be done on the principle of Quality and Cost Based Selection (QCBS) method.

The details of the process are described below:

The evaluation of the proposal shall be carried out in two stages.

In the first stage, evaluation of the technical proposal will be taken up. Proposals which are received unsigned or are incomplete (i.e. when the required bid formats and /or supporting documents, proof of deposit of requisite tender fees, EMD etc. have not been submitted along with Covering Letter) will be summarily rejected as non-responsive. Then technical documents of firms will be evaluated amongst qualifying bidders.

In the second stage, evaluation of the financial proposal will be taken up.

The weightage assigned for bids are:- Technical bids: Financial Bids = 60:40. The final assessment will be based on the total of [60% of Technical scores + 40% of financial scores].

Any proposal of modification subsequent to opening of bids and bids not conforming to tender conditions shall be liable to be rejected. Therefore, bidders are advised to submit their bids complete in all respects as per requirement of tender document specifying their acceptance to all the clauses of Bid Evaluation Criterion, General Terms and Conditions and compliance to the scope of work requirement etc.

**Evaluation of Technical Bids:** The Technical Bid will be examined by the tender committee. Evaluation will be done on the basis of evaluation criteria and scoring pattern as mentioned below:

<sup>\*</sup> Work Orders / Completion Certificates received in multiple years for same work from an organization shall be considered as a single work for the purpose of technical evaluation.

Monitoring, Survey, Research work and Inventory of Forest Establishment of Private Sector will be evaluated under Sl. No. C.3) above for the purpose of technical evaluation.

Bidders securing Technical score of 50 or above, will qualify for evaluation in the financial bid. Priority shall be given to the firm having HQ at Kolkata if more than one firm score equal marks.

#### 5. Uploading of summary list of technically qualified Tenderers (1<sup>st</sup>round)

Pursuant to scrutiny and decision of the Tender Evaluation Committee (TEC), the summary list of eligible Tenderers whose Financial Proposals will be considered will be uploaded in the web portals.

While evaluation, the Committee may summon the Tenderers and seek clarification / information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated time frame, their proposals will be liable for rejection.

#### 6. Final publication of summary list of technically qualified Tenderers

Date of opening of financial bid will to be intimated in the final summary list.

#### 7. Evaluation of Financial Bids:

Financial proposals of the Tenderers declared technically eligible by the e-Tender Evaluation Committee will be opened electronically from the web portal stated on the prescribed date, normally after 2(two) working days of date of publication of final summary list of the e-Tenderers.

The encrypted copies will be decrypted and the rates will be read out to the bidder remaining present at that time.

The Financial Bids of the technically qualified bidders will be evaluated as per the evaluation criteria mentioned below:

- The total financial score for evaluation of financial bids is 100.
- The list of Bidders will be ranked in ascending order, i.e. the Bidder who quoted the lowest amount (L1) will be ranked first and so on. For the purpose of this tender the participating bidder who would quote the lowest amount as financial quote, will be ranked L1 and will be assigned 100 points. Other bidders, viz. L2, L3 etc. will be compared against the financial quote of the L1 bidder and points will be assigned accordingly. For example, if L1 is Rs. 200/- and that of L2 is Rs. 400/-, then L1 will be awarded 100 points (maximum) and L2 will be awarded (200/400) x100=50 Points.

## Total Score Secured (under QCBS method) = 60 % of Technical Score (achieved) + 40 % of Financial Score (achieved).

In case if Total Score Secured (calculated as above) by more than one bidders ties, then lowest bidder having highest technical score will be given precedence

After evaluation of Financial Proposal, by the Tender Inviting Committee, Final summary result will be uploaded after evaluating the bids under QCBS method.

### 8. Procedures to be followed when one / two technically qualified Tenderers participated in any e-Tender:

Financial bid of technically qualified single / two Tenderers may not be opened. Re-Tender may be invited immediately in the process of evaluation as per norms of e-Tender as per G.O. No. 2320/F(Y) dated 07/06/2022.

#### 9. Acceptance of e-Tender (Technically eligible/qualified)

The Tender Accepting Authority does not bind himself to do so and reserves the right to reject any or all the e-Tenders, for valid reasons and also reserves the right to distribute the work to any other technically qualified Tenderer (L2, L3 and so on) at the L1 rate if the L1 bidder fails to accept the Third party Monitoring work within the stipulated time period.

#### 10. Penalty for suppression / distortion of facts

If any of the e-Tenderers fails to produce the original hard copies of the documents (especially completion certificates), or any other documents on demand of the Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the Tenderer will be suspended from participating in the e-Tenders on e-Tender platform for a period of 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, the **WEST BENGAL FOREST DEPARTMENT** may take appropriate legal action against such defaulting Tenderer.

#### 12. Earnest Money Deposit (EMD):

- a) Mode of EMD Payment: Payment by NET BANKING (any listed bank) though ICICI bank payment gateway.
- On selection of net banking as the payment mode, the bidder will be directed to ICICI bank payment gateway web page (along with a string containing a unique ID) where he will select the bank through which he wants to do the transaction.
- Bidder will make the payment after entering his unique ID and Password of the bank to process the transaction.
- Bidder will receive a confirmation message regarding success or failure of the transaction.
- If the transaction is successful, the amount paid by the bidder will get credited in the respective pulling account of the state Government/ PSU/ autonomous body/ local body/ PRIs etc. maintained with the focal point branch of ICICI bank at R.N. Mukherjee Road, Kolkata for collection of EMD or Tender fees.
- If the transaction is a failure, the bidder shall again try for payment by going back to the first step.

#### 13. Opening of e-Tender:

- (a) The Technical Bid shall be publicly opened by the authority receiving e-Tender or by his authorized representative, as per the Date & time Schedule mentioned in NIT.
- (b) Prospective Tenderers or their authorized representatives may be present during the opening process.
- (c) Financial Bids of only those Tenderers who would qualify in the Technical Bid evaluation will be opened.
- (d) The intending Tenderers shall clearly understand that whatever may be the outcome of the present Invitation of e-Tender, no cost of e-Tendering shall be reimbursable by the Government. The CF & JT. CEO, WB CAMPA, reserves the right to reject any e-Tender or all Tenders without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Tenderer at any stage of Tendering.
- (e) The acceptance of the Tender rests with the **CF & JT. CEO**, **WB CAMPA** who does not bind himself to accept the lowest Tender and reserves to himself the authority to reject any or all the Tenders received without assigning any reason thereof.
- (f) Intending Tenderers are encouraged to inspect the site of work and get themselves thoroughly acquainted with the local condition and all factors which may affect their rates. Prior to the site visit the intending Tenderers must inform **CF & JT. CEO, WB CAMPA** about the time and date of the visit.
- **14.** The selected bidder must arrange to procure all materials required for the proper completion of the work (as Per the Technical Specifications of the e-Tender document). The Employer will not on any account be responsible for procuring the same.

#### 15. Validity of Bids:

Bid shall remain valid for one year from the starting date of execution of works. Bid validity for a shorter period shall be rejected by Tender Accepting Authority as non-responsive.

If any Tenderer withdraws his offer before Bid validity period without giving any satisfactory explanation for such withdrawals, he may be disqualified for submission of e-Tender to this Office and Directorate of Forests, Government of West Bengal for a minimum period of 1 (one) year.

#### 16. Verification of credentials/onsite projects:

Before issuance of the work order, the e-Tender Accepting Authority may verify the credential and other documents of the lowest Tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest Tenderer is either manufactured or false in that case, work order will not be issued in favour of the Tenderer under any circumstances and legal action will be taken against him.

#### 17. Cancellation of e-Tender:

**The CF & JT. CEO, WB CAMPA** reserves the right to cancel this N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

#### 18. Security Deposit:

The successful Tenderer has to deposit Security Deposit 10% (Ten Percent) security money through Treasury Challan under H/S:- 8443-00-109-003-07-Secutiry Deposit(Operator ID 155 & Scheme ID-99997) by the Tenderer himself, within 7 (seven) days from the date of acceptance of Tender and a contract paper has to be signed otherwise the earnest money shall be forfeited to the State. Under any circumstances the Security Deposit so deposited shall not bear any interest.

#### 19. Deduction of Taxes Etc.:

Deduction of Income Tax, GST and any other extant taxes as applicable from the Bidder's Bill will be made as per Govt. rules.

20. Removal of Discrepancy:

If any discrepancy arises between two similar clauses on different notification, the clause as stated in later notification will supersede former one in following sequence: -

- a. Form of Agreement
- b. e-Tender Form
- c. Technical Specifications
- d. General Terms and Conditions
- e. Instructions to Bidders
- f. N.I.T.

## 21. Mobilization Advance/ Cost Over Run:

No Mobilisation Advance and Secured Advance will be allowed.

22. Canvassing in connection with the e-Tender is strictly prohibited.

23. The successful Tenderer will have to start the work as per the work order. The Firm has to complete different stages of work as per time frame specified in the NIT/work order. However, CF & JT. CEO, WB CAMPA may subsequently alter the time frame.

24. The bidder shall not be entitled for any compensation for any loss suffered by him due to delay arising out

A verbal authority or direction by the Tender Inviting Authority, if confirmed by the L1 bidder in writing within seven days, be deemed to have been given in writing. No claim for an extra shall be allowed unless it shall have been executed by the L1 bidder on specific direction on the Tender Inviting Authority as herein mentioned any variation i.e., additions, omissions or substitutions shall vitiate the Contract.

The employer shall thereafter ascertain and certify in writing under his hand that (if anything) shall be due or payable to or by the employer, for the value of the said plant and materials so taken possession of by the employer and the expense or loss which the employer shall have been put to in getting the work to be so completed and amount if any owing to the bidder and the amount which shall be certified shall there upon be paid by the employer as the case may be and the certificate shall there upon be paid by the employer, as the case may be and the certificate of the employer shall be final and conclusive between the parties.

The award of the arbitrator shall be final, conclusive and binding both parties to this contract and no suit shall lie in Civil Court in respect of the award by the Arbitrator.

## 6. Sampling strategy

The following definitions have been used in this section:

Project area: The area of a plantation site

Project site: This is the location where the plantation was taken up

For direct field observation, a two stage sampling strategy needs to be adopted. Of the total plantation projects taken up, first we need to select the projects to be sampled and secondly in the selected projects then take up field enumeration.

### a) Selecting the projects to be sampled

The level of precision in estimating survival percentage of plants depends on deviation admissible from true value of survival percentage at 95% confidence interval. Once the precision level is set, the sample area required in estimating survival percentage will be determined for each project site. The sample area for monitoring each project site must be calculated on the basis of the estimated variance of survival percentage in each project site. To estimate the number of plots needed for monitoring at a given confidence level, one should



obtain an estimate of survival percentage variance for each project site. This can be determined by taking a sample of 15 to 20 plots in each of the project sites.

Example to calculate survival percentage and the variance of survival percentage:

The calculations here are given assuming 25-30 trees were planted in a 0.5 hec area, 16 samples were taken from a give project site.

# Case (1): The project area across the project sites is equal and variance of survival % is also equal:

If the project area is equal for each project site, the number of plots per site = ni = N/k

 $n_i$ = sample size for ith strata

N = Total planted area

Normally, the project areas in the various locations are not equal, hence this case is practically not applicable



# Case (2): The project area across the project sites is unequal but the variance of survival % is equal:

If the project area is different, the number of plots per strata are estimated by proportional allocation, i.e., proportional to strata size.

### Case (3): The project area per site is unequal and variance of survival % is also unequal:

In this case it is recommended that, for each site the sample area may be calculated based on the variance of the survival % with respect to that particular site using equation (1).

choose 10% of the plantation area for each site as its sample size.

## b) Field enumeration in the selected projects

After studying the approaches adopted to sample multi-row block plantations by the various State Forest Departments, ICFRE and other research organizations it was felt that the row sampling approach with 10% sampling intensity would be the best tradeoff between accuracy and effort. This approach is easy to implement since the forest personnel are already attuned to this in their regular monitoring cycles. The field enumeration will cover assessment of two aspects of the plantations namely survival and growth followed by aggregation of the results:

- Assessing the survival: In multi-row block plantations, any row can be selected as initial or starting row for counting and then every 10th row should be selected. In these rows all the plants should be counted till the end of the row, either dead or surviving, for calculation of survival percentage. For example, if 2nd row has been chosen as initial or start row then subsequent rows selected should be 12th, 22nd and so on till the end of the plantation area. All the plants of every 10th row need to be enumerated. The field sampling strategy is provided for in Annexure-I.
- Assessing the growth parameters: Generally the health of a plantation in expressed in terms of growth parameters of the plants. For this we measure the plant height and plant girth. This should be done at 1% sampling. Therefore, in all the rows selected above for



survival, one start plant should be selected for height and girth measurement at collar (50 cm above the ground level for upto 3 year old plantation and 100cm above ground level for upto 5 year old plantation and for plantations older than 5 years, diameter at breast height should be taken). Thereafter, every 10th plant should be selected for further recording of height and girth. If the start plant in row one is 3rd then other plants to be measured will be 13th, 23rd, 33rd and so on. It is advised to change the start plant for growth measurement in the 12th row by using a random number between 1 to 10. If the start plant in this 11th row comes to 5th then other plants to be measured will be 15th. 25th, 35th and so on. This should be followed for all the rows. The field sampling strategy is provided for in Annexure-I and the format for collection of enumeration data is provided for in Annexure-II. The survival percentage of the plantation can be calculated as the percentage of surviving plants compared to the total plants enumerated. The growth parameters of the plantation namely plantation height and plantation girth can be averaged from the total plants for which these two parameters were measured. These plantation level indicators then need to be filled in the Plantation Field Summary Report provided for in Annexure-III.

• Aggregating the findings: For the purpose of reporting, the survival percent should be weighted by net area planted in the same model. The percentage should be reported separately for each plantation model covered for the counting. i.e. if the survival percentage for irrigated teak plantation model has to be calculated, we need to first measure the survival percentage of the sample projects. i.e. if this comes to 60% for a 40 ha irrigated teak plantation, 40% for a 100 ha irrigated teak plantation and 80% for a 20 ha irrigated teak plantation, then the weighted mean by net area planted comes to (60X40 + 40x100 + 80x20)/(40+100+20) which comes to 50%. So the overall survival percentage of the irrigated teak plantation model is 50%.
